ONLINE PRIVACY POLICY AGREEMENT

Leslie Desmond, Leslie Desmond School of Horsemanship, LLC, FEEL of a HORSE, and the Feel of a Horse ("we", "our/ours", "us"), are committed to keeping any and all personal information collected from visitors to https://www.feelofahorse.com (the "Site"), and from those who become members on our website, and / or others who make use of our online facilities and services accurate, confidential, secure and private.

We do not sell, rent or lease any of our customer lists and/or names to any third parties.

In order to improve the site and what it brings our members and visitors in the future, we may determine that it is necessary to follow websites and/or pages that our users visit to better understand what types of services and/or products our constituents need / and want more information about.

At FEEL of a HORSE, we want you to enjoy and benefit from our website and online services secure in the knowledge that we have implemented fair information practices designed to protect your privacy. Our privacy policy is applicable to http://feelofahorse.com (the "Site"). The privacy policy describes the kinds of information we may gather during your visit to the Site, how we use your information, when we might disclose your personally identifiable information, and how you can manage your information.

This privacy policy does not apply to sites maintained by other companies or organizations to which we may link or who may link to us. We are not responsible for the actions and privacy policies of third-party websites.

Acceptance of Privacy Policy Terms and Conditions

By joining and using this website you agree that you have read, understood and accepted, prior to submitting a payment, the terms and conditions herein stated concerning this Privacy Policy Agreement, including our use of cookies and similar online tools. If you do not agree to the terms of this privacy policy, please do not use the site.

Further, we reserve the right to modify or amend the terms of our privacy policy from time to time without notice. Your continued use of our site following the posting of changes to these terms will mean you accept those changes. If you determine at a later point int time that are not in agreement with our terms and conditions, then you should immediately refrain from further use of our Site.

If we intend to apply the modifications or amendments to this privacy policy retroactively or to personally identifiable information already in our possession, we will provide you with notice of the modifications or amendments.

What Information Is Collected?

We collect two basic types of information from you in conjunction with your use of the Site: non-personally identifiable information and personally identifiable information. Non-personally identifiable information does not individually identify you, but it may include tracking and usage information about your general location, demographics, use of the Site and the Internet. Personally identifiable information is any information that can individually identify you and includes, your name, address, phone number, and email address, or non-personally identifiable information that has been linked to such personally identifiable information.

Personally, Identifiable Information

You can browse the Site without submitting your personally identifiable information. Non-Personally Identifiable Information

When you interact with the Site, we may collect certain information that does not identify you individually ("non-personally identifiable information" or "non-PII"), such as demographic data; information about your computer, mobile device, browser, or other device that you use to access the Site, including IP address, general location information, unique device identifiers, browser type, browser language, and other transactional information. We may also collect information about your use of the Site, including your search terms and search results, and additional "traffic data" such as time of access, date of access, software crash reports, session identification number, access times, and referring website addresses. Our servers may automatically keep an activity log of your use of our Sites. In addition to non-identifiable individual information, we may collect aggregate data regarding the use of the Site.

Collection of Personally Identifiable Information From or Through Social Media Sites

In addition, when you interact with any FEEL of the HORSE property page or account on a social media platform, such as Facebook we may collect the personally identifiable information that you make available to us on that page or account including your social media account ID. However, we will comply with the privacy policies of the corresponding social media platform and we will only collect and store such personally identifiable information that we are permitted to collect by those social media platforms. If you choose to link or login to your FEEL of a HORSE account with or through a social networking service, FEEL of a HORSE and that service may share certain information about you and your activities. If you have questions regarding any given social media platform's privacy policies refer to their site for details.

Collection of Your Source IP Address/Location Information

We collect and store your device's source IP address which may disclose the general location of your device at the time you access the Site.

Information from Other Sources: We may supplement the information we collect with information from third parties or collected offline and add it to your account information. This information may include name, address, and phone numbers to in order to deliver products you have purchased.

How Do We Use Your Information?

We use the information we learn from you to help us personalize and continually improve your experience on the Site, including to:

- Provide you with the content, products and services you request
- Post your user generated content to our Sites as you request
- Communicate with you about your account or transactions with us and send you information about features and enhancements on or to our Sites
- Communicate with you about changes to our policies
- Communicate with you about your comment to a story or topic

We may use the information from one portion of this Site on other portions of the Site; and we may combine information gathered from multiple portions of the Site into a single user record. We also may use or combine information that we collect offline or we collect or receive from third-party sources for many reasons, including to enhance, expand, and check the accuracy of our records. Additionally, data collected from a particular computer, browser or device may be used with another computer, browser or device that is linked to the computer, browser or device on which such data was collected.

Who Can See Your Information?

We will not disclose your personally identifiable information collected from the Site to any person or organizations not working on a strictly confidential (contractual) basis with, or for Leslie Desmond, Leslie Desmond School of Horsemanship, LLC, Desmond Outfitter, LLC, or Diamond Lu Productions, LLC, except as described in this privacy policy.

However, in a rare and unlikely circumstance, we may disclose your personal information, without prior notice to you, only if required to do so in accordance with applicable laws and/or in a good faith belief that such action is deemed necessary or is required in an effort to:

- Comply with any decrees, laws and/or statutes; or, in an effort to comply with any
 process which may be served upon Leslie Desmond and FEEL of a HORSE and/or our
 website;
- Maintain, safeguard and/or preserve all the rights and/or property of Leslie Desmond and FEEL of a HORSE; and
- Uphold our commitment to safeguard the personal safety of users of https://www.feelofahorse.com and/or the general public. However unlikely, these are the only reasons this would occur, and not without the compelling advice and direction of legal counsel.

Third-Party Agents

We have third-party agents, subsidiaries, affiliates and partners that perform functions on our behalf, including, but not limited to, hosting, content management tools, social media integration, marketing, analytics, billing and customer service. On a strictly confidential, contractual basis, these entities may have access to personally identifiable information if needed to perform their functions. If such access is required, the third parties will be obligated to maintain the confidentiality and security of that personally identifiable information. They are restricted from using, selling, distributing or altering this data in any way other than to provide the requested services to this Site.

Links to Other Web Sites

Our website contains links to affiliate and other websites. We do not claim nor accept responsibility for any privacy policies, practices and/or procedures of other such websites. We encourage all users and visitors to be aware when they leave our website and to read the privacy statements of each and every website that collects personally identifiable information.

This Privacy Policy Agreement applies only and solely to the information collected by our website.

Assignment

In the event of a corporate change in control resulting from, for example, a sale to, or merger with, another entity, or in the event of a sale of assets or a bankruptcy, we may transfer your personally identifiable information to the new party in control or the party acquiring assets. Under such circumstances we would, to the extent possible, require the acquiring party to follow the practices described in this privacy policy, as it may be amended from time to time. Nevertheless, we cannot

promise that an acquiring company or the merged company will have the same privacy practices or treat your information the same as described in this privacy policy.

Law Enforcement, Legal Process, and Emergency Situations

In some cases, we may use or disclose your personally identifiable information to a third-party if we are required to do so by law or if we in good faith believe that such action is necessary to comply with the law or legal process; to protect and defend our rights or to prevent misuse of our Sites; or to protect the personal safety of our employees, agents, partners, the users of the Site, or the public.

Use of Non-Personally Identifiable Information

We may disclose or share individual, non-personally identifiable information and aggregate information in any manner other than that described herein that we deem appropriate or necessary. How Your Information Is Secured
